### BOOTH INFORMATION

Booth fee includes 8 foot pipe and drape, one six foot table-skirted and draped, one 110 electric service, vendors should provide extensions cords; 2 chairs, name and location sign and wastebasket. Drapery cannot be used for display. All hanging displays within the booth are to be hung on S-hooks and rods, or separate poles and rods. Displays are not to extend over 8 feet in height. All tables used in the booth must be draped to the floor, no packing boxes are to be visible. Sales tax must be collected at the current rate. If you do not have a Colorado license, you must fill in a form that will be supplied with the rest of the tax information in your acceptance packet. Booths must be attended at all times. Order forms for extras will be provided in the exhibitor packet.
